

**Privacy protection of Information – Guarantors
Privacy (Privacy Sector) Amendment Act 2000 (Cth)**



To: Hermes Capital Partners Pty Ltd ACN 137 386 791 (HERMES)

We, the undersigned, acknowledge and authorise Hermes as follows:

1. Acknowledgment and authority that credit information may be given to a credit reporting agency

We understand that Section 18E(c) of the Privacy Act allows HERMES to give a credit reporting agency personal information about us. We authorise HERMES to give this information. We are aware that the information which may be given includes:

- Identity particulars
- The fact that we have offered to act as guarantors in respect of a loan to, or an application for a loan by the borrowers named below.
- The fact that HERMES is a credit provider to us.
- Any payments overdue more than 60 days are, and which collection action has commenced.
- Advice that payments are no longer overdue.
- In specified circumstances, that in HERMES's opinion, we have committed a serious credit infringement.
- That the credit provided to us by HERMES has been discharged.

We acknowledge that if we elect not to disclose our personal information, HERMES may be unable to adequately provide us with its services.

2. Authority for you to get credit information

To enable HERMES to assess whether to accept us as guarantors for credit applied for by, or provided to, the borrowers named below, we authorise HERMES to get reports from a credit reporting agency or other business that provides information about credit worthiness. We are aware that these reports may contain:

- Personal information about us.
- Personal credit information about us. This is in accordance with Section 18K(1)(c) of the Privacy Act.
- Other information in relation to our commercial activities.

3. Authority to exchange information with other credit providers

In accordance with Section 18N (1)(b) of the Privacy Act, we authorise HERMES to give information to and get information from all relevant credit providers or credit reports issued by a credit reporting agency. We understand this can include information about our credit worthiness, credit standing, credit history or credit capacity.

We understand the information may be used for the following purposes:

- To access whether to accept us as guarantors.
- To assist us to avoid defaulting on our credit obligations.
- To tell other credit providers about a default by us.
- To assess our credit worthiness.

We acknowledge that our personal information is only disclosed to third parties where we have expressly consented at the time of providing the information or, the law requires the disclosure.

4. Access to Records and Correction

HERMES will provide us with access to its record of our personal information on request to our Privacy Officer on (02) 9690 0611.

HERMES will allow us access in a form or manner suitable to our needs, unless it is unable to do so by law or is legally entitled to refuse us access.

5. Banker's opinions

We authorise HERMES to give and receive banker's opinions about our business, trade or profession.

6. Duration of agreement

We agree that if HERMES approves the borrower's application for credit, this agreement remains in force until the credit facility covered by the borrower's application ceases.

7. Privacy Statement

We acknowledge having received HERMES's privacy policy.
